



## **SDM FLIX, LLC Television/Film Broadcasting Agreement**

This is an agreement between Alaina Kerr and SDM FLIX, LLC hereinafter referred to as (Broadcaster), granting broadcast rights for the television/film production titled Journey To The Spotlight (Title of Production) to be broadcasted on SDM FLIX, LLC on the date agreed and other broadcast networks set forth by the Broadcaster. Both parties agree to the following:

1. This agreement grants (Broadcaster) the license right to broadcast and/or rebroadcast the production titled Journey To The Spotlight and to be broadcasted and/or rebroadcasted on the television/film outlets set forth by (Broadcaster) including but not limited to; Roku TV, Fire TV, Apple TV, and other digital television incorporated, or outlets set forth by (Broadcaster).
2. Alaina Kerr shall have liability insurance coverage sufficient to hold the (Broadcaster) harmless from any accident claim that may result from the action of the broadcaster's employees or agents, malfunction of equipment, collapse of platform, or any other structure or device which is the property or responsibility of the broadcaster or its agent.
3. Alaina Kerr will produce eight 30-45 minute episode of the production titled Journey To The Spotlight to be broadcasted by the (Broadcaster) on the television network set forth by (Broadcaster).
4. Alaina Kerr will earn a 6% royalty on all net earnings and merchandise products earned by the production titled Journey To The Spotlight and will be paid on a monthly basis via direct deposit or other payment option set forth by the (Broadcaster). First royalty payment will be issued via direct deposit by (Broadcaster) after 60 days from the date of production publication.
5. (Broadcaster) will promote the television/film production produced by SDM FLIX LLC/LEK LLC on the SDM FLIX network platform throughout the United States using but not limited too; emailing/texting subscribers, by social media platforms and other broadcasting networks set forth by (Broadcaster).
6. This contract is binding to confidentiality throughout the filming of the production titled Journey To The Spotlight and will not be displayed to the public until published by (Broadcaster).
7. This agreement becomes binding when the agreement is signed by the (Broadcaster) representative and Alaina Kerr.
8. (Broadcaster) has agreed to publish the production titled Journey To The Spotlight within the year 2021 of the finale production.
9. The duration of this contract will be perpetual and exclusive to SDM FLIX, LLC for two years.
10. (Broadcaster) will be the sole owner of the production titled Journey To The Spotlight and will retaining exclusive rights of the production titled Journey To The Spotlight for a duration of a lifetime.
